A forthcoming CIC #4 Request for White Paper (RWP) will require prospective vendors to submit proposals at the unclassified level but which will require operation at the Top Secret/Sensitive Compartmented Information (TS/SCI).

- "The model described above can help decision makers plan for expanded COVID-19 testing scenarios. It determines the most optimal facilities and which populations to direct them to. By designating specific block group geographies to specific testing locations, this allows facilities to be prepared for the incoming patients. The results can also highlight the demand (population) and provide realistic capacity values for the potential number of COVID-19 test availability at each optimal location."
